CORRESPONDENCE

An email was received from Bonnie Cortese concerning postings of campaign expense reports on Facebook (Subject: Complaint regarding Build a Board). Attorney Miscavige advised the board he does not believe the posting constituted a violation of the Election Code.

Correspondence was received (presented to the solicitor at the Commissioners' Meeting of May 9) from Chris Lukasevich (Subject: Ethics Violation Complaint). Attorney Miscavige provided the board a memorandum addressing the correspondence. The memorandum states "There is no provision in the Election Code authorizing the Board of Elections to review or investigate allegations of alleged ethical violations of either a candidate or of a current elected official." The memorandum also states "... there is no allegation or specified violation of the Election Code..." in the correspondence. (Client Attorney Confidential Communication)
