INSTRUCTIONS TO BIDDERS

1. The buses and vehicles are being sold in “as is” condition.
2. The minimum bid amount is \$700.00 per BUS.
3. Bidders may submit bids on multiple buses or vehicles, **but**

A) Bids must be submitted (1) per envelope.

B) Envelope must clearly state your name, address and the bus or vehicle number you are bidding on, for example: “Used Bus #954” or Vehicle #1.

4. For security reasons, the inside of the buses and vehicles may only be viewed on Monday, January 7, 2019 between 8:00 A.M. and 2:00 P.M. at the far end of the Carbon County Parking Lot located on Lehigh Avenue, Jim Thorpe, PA 18229.
5. Deadline for submitting bids is 3:30 P.M., Monday, January 14, 2019. Submit your sealed bid, clearly marked on the envelope with your name and address and the words “**BID FOR USED BUS # ____ or Vehicle # _____**” to:

6. Sealed bids will be opened at the Board of Commissioners Meeting held on Thursday, January 17, 2019 beginning at 10:30 A.M. in the Commissioners Conference Room, Carbon County Administration Building, 3rd Floor, Jim Thorpe, Pa. It is not mandatory for bidders to attend the bid opening.
7. Successful bidder(s) will be contacted by the County to make arrangements for payment and pick-up.
8. Payment in the form of Cash, Certified or Bank Check only, payable to “County of Carbon”, must be received by the County within 7 days of bid award. If payment is not received by the County within 7 days of award, bidder forfeits any and all rights to the vehicle(s).
9. All vehicle transfer costs are the responsibility of the bidder and must be done in person.
10. All vehicles must be removed from County property no later than Thursday, January 31, 2019. If bidder fails to remove the vehicle(s) on or before that date, the bidder will forfeit any and all rights to the vehicle(s), and bidder shall not be entitled to a refund of any monies paid.
